II. Old Business

- Financials (Year end report)
 - Bruce Lichtenberger (WF's Accountant) gave the year end report for 2005 including expenses and assets. (See the WF website for the financials.)
 - WF Board approved the financials.
 - Motion and approval for Ken Eberly to investigate best type of interest bearing account at New Frontier bank and to transfer \$50,000 from operating account.
- Newsletter
 - Ken presented a draft of the WF newsletter.
 - New Complaint process will be added on the front page.
- Unit #504 Water Leak Report
 - Mold abatement company (Risk Removal) has been out and given a proposal.
 - Motion and Approval for moving forward.
- Noise Complaint Process (Fines?)
 - Motion and Approval of a Process and fine system put into place by the WF Board:
 - 1st Substantiated Complaint: Warning letter sent out
 - 2nd Substantiated Complaint: \$150 fine
 - 3rd Substantiated Complaint: \$300 fine
 - 4th Substantiated Complaint: \$500 fine
 - 5th Substantiated Complaint: Legal Action
 - In order for a noise complaint to be substantiated, see the following:

- 1) Two residents must submit written complaints about the same noise violation.
- 2) One resident may submit a written complaint AND have proof of a police report (case #)
- 3) One resident may submit a written complaint AND call the on-site manager when the noise is taking place in order for him to come and hear the noise violation.
- Pet Waste & garbage
 - More doggie bag posts may need to be installed.
 - Need to get the committees more involved with pet responsibilities and ownership.

III. New Business

- Chris Dinkel offered to resign from the Board as his new place of employment takes him away more than before. However, the WF Board invited Vikki Dinkel to attend meetings as his proxy if he needs to be away during any given Board meeting. Vikki accepted the invitation.
- Alpine Proposal (Landscaping)
 - Spring proposal approved by WF Board.
 - Before the proposal/contract is signed, the down spouts/drainage pipes need to be replaced.
- American Family Insurance (New premium)
 - New premium decreased from \$26K to \$20K for the coming year.
 - Encourage all residents to have a condo owner's insurance policy. Scott Bicknell [330-8887] can assist folks with this.
- Management Proposal
 - Howard has been the on-site manager at WestFork since the clubhouse opened and has not received an increase in salary (over 2.5 years).
 - Motion and approval of the proposal for a small increase in salary.
